

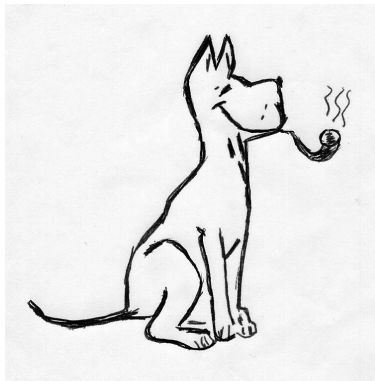

## Old Friends

From time to time people have mentioned to me a problem they have with their dog of phobia to thunder, fireworks, loud noises, etc. This can occur in a young dog or sometimes as the dog gets older.

Most owners do not realize how they have either caused or contributed to their dog's fears and have no idea how their own actions influence their dog's behavior.

Owners do not know what to do when the dog shows signs of a problem and they end up doing the wrong thing. They attempt to reassure the dog and say such things as "It's OK. Be a good dog". The dog associates these words with being afraid as having the owner's permission that "It's all right" and that being afraid is

acceptable behavior.

There also are owners who yell at their dog and they become more frightened and associate loud noises with punishment.

So what is the solution? Say nothing to the dog whenever it shows a fear to loud noises. Ignoring an undesirable behavior sometimes helps put it to an end. It is also necessary to teach a dog to do something to keep it busy when the loud noise occurs. Even if you just teach it to heel and sit and keep the dog moving at a quick pace.

The following is a system you can try to desensitize your dog.

Play classical music while feeding your dog or scratching his ears so the dog associates the music as pleasant. Once the dog feels comfortable with the music, play the music along with a tape of the noise your dog is afraid of. Keep the volume low to start. If the dog shows signs of stress stop the recording and wait at least 1 hr. before renewing the procedure. This is a gradual conditioning and with patience and perseverance noise phobias can be cured.

In some severe cases you may need the help of a veterinarian to control the problem. Some dogs do well crated or kept in a confined area. Another mistake owners make when leaving their dogs at home alone is what they say as they are leaving the house. If you make a big fuss and get the dog excited as you leave this causes him to have an anxiety problem. Your best bet is to ignore the dog, get him used to one word as you leave, such as "wait" and leave without a big to do.

This also goes along with your return that you don't get excited when you see your dog and have him out of control on your return. Both of these mistakes on your part contribute to the dog's anxiety.

It seems that despite thousands of years of domestication most dogs are concerned with status. Dogs always want to know who's in charge, and if the owner's aren't, they will try to be. After all, every pack needs a leader and most dogs don't have a problem with you as "Top Dog".

Properly socializing and shaping your puppy's temperament requires an investment in time. You will find that your efforts are worthwhile when you become the proud parent of a social friendly dog.

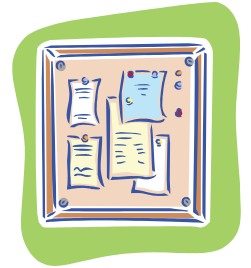
Kelly Pastuszek asked if people had checked the up-dated web-site and everyone liked the new format.

# Sherry's Corner

## DOG LAW ADVISORY BOARD

Various newspaper stories have stated that the Dog Law Advisory Board was fired by Governor Rendell allegedly because he believed they were not doing enough about puppy mills in Pennsylvania. It occurred to me that probably many dog owners do not know who is on the Advisory Board and how it came to be. The Board was set up by the Dog Law (Act of 1996 with Amendments, No. 151) The Board is set up by the Secretary of Agriculture to advise him in the administration of the law. According to the Dog Law there is to be a representative of animal research establishments, a representative of the Pennsylvania Veterinary Medical Association, two representatives of animal welfare organizations, three representatives of farm organizations, a representative of dog clubs ( Pennsylvania Federation of Dog Clubs) a representative of commercial kennels, a representative of pet store kennels, a representative of sportsmen and hunting organizations, a representative of a national purebred canine pedigree registry, a representative from lamb and wool growers, a county treasurer, and a representative of the police. In order for any other group to be represented, legislation amending the Dog Law would need to be enacted. For example, In 1995 I wrote to then Representative John Gordner asking him to include an eleventh member--an animal education organization. I felt then as I still do that a vital aspect of the process and procedures relating to the dog law has been education of pet owners about the proper care and handling of companion animals. I was then and continue to believe that material pertinent to dangerous dogs and therapy dogs needs to be part of dog law discussions.

The terms of each appointment to the board are set by the secretary and staggered. The Board may make nonbinding recommendations to the Secretary on all matters related to the Dog Law.

Who was fired by the Governor? Did he have to power to fire the members? Why didn't the Secretary of Agriculture fire the members he appointed?

All of this has been widely written about by a Philadelphia Inquirer columnist. It has fanned distrust among the many groups who care about dogs. Supposedly the animal rights groups are taking the lead in this influences battle by labeling all others who care about dogs as "users" and "breeders". Users may do pet therapy, enter performance events such as Rally, herding, obedience . Breeders are the worse because they do not know what they are doing and are adding to over-population problems.

The columnist who has picked up the banner is none other than John Grogan author of the number one New York Times bestseller, "Marley and Me" life and love with the world's worst dog. I intend to read this book in order to access the influence of this author on Pennsylvania's most shameful image and politics in the Commonwealth. Right now it would seem that the author needs to meet the Dog Whisperer, another author of a current best selling book!
